This site is designed with three goals in mind:

1. Increase awareness and understanding of our state's Eligible Content – the grade by grade statements that define what we want our students to be able to know and do
2. Solicit actionable feedback on the Eligible Content as part of the Pennsylvania Department of Education's review process
3. Provide PSSA/Keystone Exam sample questions for English Language Arts and Mathematics for each tested grade/subject.

As stated above, the Eligible Content statements define what we want our students to be able to know and do and provide the most specific description of the skills and concepts assessed on the PSSA and Keystone Exams.

The department is seeking specific feedback on the English Language Arts and Mathematics Eligible Content.
