JOINT STATEMENT: GENERAL ASSEMBLY MUST SUPPORT BUDGET WITH ADEQUATE SCHOOL FUNDING

HARRISBURG, PA (March 3, 2015) – As state legislators consider Governor Tom Wolf's 2015-16 budget proposal, citizens of the Commonwealth are watching to see if their elected officials will support a quality education for children in every community. Pennsylvania's major education leadership organizations, representing all 500 school districts, today called on the General Assembly to approve Governor Wolf's budget request and adopt a new state funding formula that will ensure equity and adequate funding for all schools beginning next school year.

"Education is the lynchpin for achieving the goals set forth in Governor Wolf's proposal for economic development and creating good-paying, middle class jobs. Our state must adequately fund education and ensure taxpayer dollars are equitably distributed to strengthen our schools' ability to prepare students for careers throughout Pennsylvania. Today's young people are tomorrow's skilled workforce if we invest in their futures."
