## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in certification of teachers, further providing for continuing professional development, for 5 6 program of continuing professional education and for charter schools. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 1205.1 of the act of March 10, 1949 12 (P.L.30, No.14), known as the Public School Code of 1949, is 13 amended by adding a subsection to read: 14 Section 1205.1. Continuing Professional Development .-- \* \* \* 15 (q) Beginning on the effective date of this subsection and notwithstanding any other provision of this section, each school 16 17 entity shall have one additional year to submit to the secretary for approval a three-year professional education plan as 18 required under subsection (a). During the additional year, the 19 school entity's current professional education plan may remain 20

- 16 Section 1205.3. Charter Schools. -- [An] (a) Subject to
- 17 <u>subsection (b)</u>, an uncertified teacher or administrator who is
- 18 employed full time by a charter school shall comply with the
- 19 continuing professional education requirements of sections
- 20 1205.1 and 1205.2(a) through (c) to maintain employment in a
- 21 charter school. The charter school shall maintain the records of
- 22 an uncertified teacher or administrator who is employed full
- 23 time by a charter school.
- 24 (b) Beginning on the effective date of this subsection and
- 25 <u>notwithstanding any other provision of this section, the current</u>
- 26 continuing professional education compliance period of each
- 27 <u>uncertified teacher or administrator who is employed full time</u>
