Personal Excellence

- · Models continuous professional growth
- Interacts professionally and tactfully with others
- Communicates effectively in speaking and writing
- Models values, beliefs and attitudes that encourage others to higher levels of performance
- Demonstrates commitment to NASSP and its programs through continuous membership and participation in state affiliate student leaders.

Collaborative Leadership

- Involves teachers, staff members, parents, students and the community in creating and fostering a shared vision for the school
- Leads collaboratively to promote ownership among staff, students, parents and community members for school efforts and outcomes
- Creates a culture of collaboration in which staff members work together as a professional learning community to promote student learning
- Identifies, coaches and supports the development of potential and current school leaders
- Utilizes available technology to effectively address issues in the school community and meet unique learning needs of each student.

- Implements practices and programs based on multiple sources of data that improve teaching and learning
- Identifies and aligns essential learnings at each level with the curricula and standards

Personalization

- Establishes and maintains a school environment that reflects high expectations for students and staff members
- Creates a school climate that is warm, inviting, safe and secure
- Provides equal access and support needed for student success to all social, economic, and racial/ethnic groups

- Regularly acknowledges the accomplishments of students, teachers and school community members

Eligibility

Any assistant principal or equivalent, (e.g., vice principal, associate principal or dean) of a public or private **middle level or high school**, is eligible to be nominated as a State Assistant Principal of the Year candidate. Middle level and high schools are defined as those that include at least two or more grades 6 through 12. All candidates must complete the online application to be considered for the National NASSP Assistant Principal of the Year award.

All applicants must hold PA Principals Association (secondary) and NASSP membership when nominated and at the time of selection as State Assistant Principal of the Year. All applicants must have been in an assistant principalship at one or more middle level or high schools for three (3) or more consecutive school years. Each candidate must be an assistant principal at the time of selection as State Assistant Principal of the Year and through January 1st of his/her term. (See the website for national specifications)

This program is designed to recognize the outstanding leadership of active, front-line assistant principals. It is **not a recognition of service at retirement or a program to reward current state or national leaders**.

Current staff members and family members of the NASSP Board of Directors are ineligible. Board members of NASSP are ineligible for consideration for one (1) year after completion of their service. Members of the PA Principals Association Executive Committee are also ineligible.

Applications from one year do not carry over to the next year; however, prior applicants are encouraged to submit a <u>new</u> application.

If you are interested in nominating an assistant principal for this award, please complete the brief nomination form enclosed with this letter. The completed nomination form must be **emailed to Georgia Shaffalo at shaffalo@paprincipals.org no later than Thursday, September 6, 2018.**

As soon as we receive your nomination form, the online award application instructions will be sent to any qualified nominees for him/her to complete. Since the <u>completed applications must be submitted online no later than Friday, November 2, 2018,</u> you are strongly encouraged to make your nomination as early as possible giving them as much time as possible to complete the online application process and obtain his/her letters of recommendations. <u>It may be helpful for you to share this letter with your nominee as it contains some important information for him/her to know.</u>
